# INTERACTIVE WORKSHOP 'SOLUTIONS FOR REMOTE WORKING BY SMALL COMPANIES'

CEAI organised a Webinar for the Interactive Workshop 'Solutions for Remote Working by

Small Companies' on 18th July 2020 which was focused on the immediate requirements for small consulting companies to modernise infrastructure, upgrade its software and hardware, to be better prepared for seamless conduct of businesses during future such eventualities, and optimise productivity.

Mr Amitabha Ghoshal, President CEAI welcomed the participants. In his welcome address he stressed that this webinar has been specially designed for the consultants



who have small or medium size offices. He briefed about the difficulties being faced by the consultants and the solutions while working from home during the pandemic.

Ms Sayona Philip, immediate Past President of CEAI, was the Moderator for the webinar.



Mr Pravinchandra Shahu, Business Head – Digital and Advance Technology IT& ADC, Tata Consulting Engineers Ltd was the speaker. He explained how we should enable ourselves for remote working. In his presentation he covered Cloud based Solutions /Facilities Required/ Modalities for shifting to remote working/ Budgetary requirement/ Typical Case Study.

# REPORT ON WEBINAR ON "INTEGRITY & TRUST IN THE CONSULTING AND ENGINEERING INDUSTRY"

A webinar on "Integrity & Trust in the Consulting and Engineering Industry", 16<sup>th</sup> July 2020 was organised by Power Engineering & Consulting JS Company (PECC3), Vietnam with support from FIDIC Integrity Management Committee and FIDIC Future Leaders Committee. All speakers stressed on the importance of Integrity in the business of the Consulting and the Engineering Industry.

Mr. Jitendra Kumar Singh as the Vice Chair of FIDIC-ASPAC Future Leaders Committee was the speaker from India and CEAI. He made an excellent presentation and substantially and meaningfully contributed to the discussions.

Mr. Thai Tuan Tai, President PECC3 welcomed the speakers and the participants. He outlined PECC3's path for Integrity Management. He linked Humility to Integrity and went on to outline the 2020 GOAL: Building a culture that is Trustworthy within Individual, Groups, Divisions and the whole Company.

Mr. John Ritchie, Member of **FIDIC** Management Integrity Committee dwelt on the aspect of a consultant being a "The Trusted Advisor" and that the aim of a Consultant should be to develop relationship. He that



explained as to what The Trusted Advisor should do to achieve that status. He showed the linkage between the "trusted advisor" and Integrity Management.

Mr. Richard Stump, Member of FIDIC Integrity Management Committee explained the FIDIC Integrity Management System (FIMS), the Guideline documents that FIDIC developed on the Policies and Principals of FIMS and how they can help Consultants go up the chain of Integrity. He also explained as to how FIMS could be adopted to ISO 37001 which is an Anti Bribery Standard.

Mr. Jorge Diaz Padilla, Chair of FIDIC Integrity Management Committee spoke of the status of Integrity the World over. He said that as per Transparency International, which has been listing companies on ethical business practices for the past 50 years, it is an uphill task. There has been no progress because we have not been able to tackle the 3 aspects—Supply Side—Demand Side—Condoning Side. It's when these are curbed that the practices would change and business Integrity would get a boost. He reiterated that quality, integrity and sustainability are the three pillars of a project.





Mr. Jitendra Singh stressed on the Importance of Integrity and explained the common dilemmas faced by Future Leaders. He discussed as to why unethical practices continue and gave examples of various situations. He concluded with, what the system structure ought to be to nurture a culture of Integrity.

Mr. Cosmin Tobolcea, Chair of FIDIC Future Leader Committee talked on the Vision of Future Leaders and their Purpose, the objectives of FIDIC and that Integrity is an important aspect. He also explained the activities of the Future Leaders Committee.

Mr. A P Mull, GC Member and Chairman, CEAI Publication Committee, participated and also interacted during the Q&A session.

# CEAI urges govt to revisit L1 tendering system

KOLKATA, 15 JULY

The Consulting Engineers Association of India (CEAI), the apex body of consulting engineers in the country, has urged the government to revisit and say good bye to the age-old conventional L1 tendering and procurement system in the country

The least cost selection method or L1, which is the award of work to the lowest financial offer, has been a prevalent procurement strategy for procurement of works by contractors, consultants and purchase of goods for a long time in the country. This has often resulted in poor quality of works and goods, CEAI said.

This necessitates an urgent need to change the selection mechanism and move

towards the concept of "workable rates'" procurement mechanism, it added.

K K Kapila, chairman, infrastructure committee of CEAI and mentor of this movement, said: "The changed procurement system which offers various alternatives to derive workable rates in a transparent manner, will give opportunities to competent firms to plan a project or a bid on workable rates, thereby facilitating better management and execution which will reflect on quality and timelines." The L1 system, which is plagued

with delays of time and cost overruns, will ultimately lead to time consuming arbitrations and higher costs, he said.

Amitabha Ghoshal, president, CEAI, said that the heart of this change lies in creating awareness in the minds of the general public that the focus on "least cost factor" has resulted in compromises in achieving world-class infrastructure or purchase of quality goods as well as services.

The country needs a public procurement mechanism which focuses on quality and costin all activities in public domain, Mr Ghoshal said.

"It is time to say goodbye to this age-old system and wake up to the dire necessity of change which is inescapably required for moving towards Atma Nirbhar Bharat," said Mr Kapila.

## International Thermonuclear Experimental Reactor (ITER)

ITER (International Thermonuclear Experimental Reactor) is an international fusion reactor being constructed under the collaborative efforts of seven participating countries including India. This experimental and collaborative research aims to create sustainable energy for the world by harnessing nuclear fusion to solve the world's energy requirements. ITER nuclear fusion research and engineering megaproject is the world's largest magnetic confinement plasma physics experiment, and TCE has been involved in the projects since inception.

TCE provided the detailed engineering of the Cooling Water System for the project. TCE was also a part of the conceptual design phase and preliminary design phase which formed the foundation for their final design.

Currently, 50+ TCE engineers from different specialisation are working at the site to help ITER deliver the Engineering Work Packages to the Construction Team for Erection. TCE is also supporting ITER through offshore projects being executed by the delivery teams in India

### Engineering Consultants for NPCIL's First Indigenous 2x700 MWe PHWR at Kakrapar, Gujarat

The Kakrapar Atomic Power Plant located at Kakrapar, near Surat in is the first indigenously designed and built Pressurised Heavy Water Reactor (PHWR) unit of 700MWe capacity. Tata Consulting Engineers (TCE) worked very closely with NPCIL on the project and provided consulting engineering services for:

- Detailed engineering including preparation of P&ID's, Specifications, Datasheets, Piping layouts, HVAC layouts, Earthing and Lighting Diagrams, Tray Layouts, Elementary and Wiring Diagrams and Instrument Specification Sheets
- Development of an integrated 3D model for the Nuclear Island which included entire reactor system along with safety systems, utilities and secondary cycle.
- Complete engineering and 3D modelling of BoTIP (Balance of Turbine Island Package) for this Nuclear reactor.
- Development of first Mobile Fuel Transfer Machine for 700 MWe PHWR.

This was the first time such an integrated 3D engineering was performed for an indigenous Nuclear Power Plant. TCE is proud to be associated with the Design Engineering of the unit.
