Dear Members and Friends,

The Governing Council (GC) for the term 2023-24 of CEAI held its first meeting on the 4th January, 2023, in which the vacant positions were filled by nominations of suitable members in the relevant category and the Chairpersons of various Committees were appointed. By the time the second meeting of the GC was held on 26th February, most of the Committees were constituted and had finalized their Terms of Reference. In the month of March the Committees have moved ahead to achieve their goals.

Members had been raising issues which need to be addressed by the concerned authorities. Accordingly, CEAI had sent representations to the Chairman NHAI, the Managing Director, NHIDCL, and the Director, DFCC and are following up with them. Low bids have been a major concern in the highway sector as it has got a direct effect on the quality of output. A representation has been sent to the ADB, Manila to provide higher weightage to Technical ranking for the award of Consultancy in Multilateral Funded projects.

The Hon'ble Minister of Road Transport and Highways has been raising the concern of quality in DPR. A number of steps for the improvement of quality in the deliverables by the Consultants, and the work and data submitted by the Investigation and Survey agencies are being planned for implementation in due course.


VIEW POINT

FIDIC TRAINING PROGRAM



Consulting Engineers Association of India organised a 3-day in-house training program from 1st March to 3rd March 2023 for the National Association for Professional Engineers and Consultants Kazakhstan. The training was attended by 54 participants. Mr. Bogdan Oprea, a FIDIC accredited trainer conducted the training.

The training focused on *FIDIC Module 1: Practical Use of FIDIC Conditions of Contracts*.

MEETING WITH CONSULTANTS



A meeting was convened by the President CEAI on 17-03-2023 at the request of consultants in the highway sector to discuss and evolve a strategy of improving the quality of DPRs often flagged by Hon'ble Minister of Road Transport and Highways, Shri Nitin Gadkari in various forums.

It was a hybrid meeting in which

a number of leading consultants participated. During the meeting, the various factors affecting the quality of DPRs and possible ways of bringing improvements were suggested by the members. Some of the suggestions that emerged in the meeting are listed below:

- a) Low rates quoted by the consultants.
- b) Requirement of DPRs in hand in the RFP of supervision contracts.
- c) Shortage of expert professionals
- d) Insufficient time assigned for DPRs
- e) Payment Schedule not commensurate with expenses incurred.



f) The Land Acquisition, utility relocation, and Environment/forest clearance may be kept out of engineering consultancy. For these activities, specialist agencies may be appointed.

After due deliberations on the way forward, the following decisions were taken:

- i) With a view of improving the system, it was decided to hold a full-day workshop in collaboration with the Ministry of Road Transport and Highways inviting all stakeholders so that all aspects including supervision and quality in construction could also be deliberated.
- ii) It was also decided that CEAI could propose to the MORTH to develop a model DPR for a real highway project section of about 100 km length on international standards which could be used as a template for future projects. The modalities of scope, funding, and implementation may be worked out in consultations with the Ministry/ NHAI.



CEAI SURVEY ON QUALITY IN CONSTRUCTION

India has embarked on major infrastructure development programmes. In the process it is witnessing a major construction boom. Quality is one of the main factors in the success of sustainable and durable development. Quality of construction projects, timely delivery, can be regarded as fulfilment of expectations of various stake holders.

Unfortunately for the majority of projects, the cost and time parameters are the main factors of worry for everyone involved, directly or indirectly with these construction projects. The quality in the construction industry is linked with client's satisfaction and the implementation of a Quality Management System (QMS) is a key tool for consistently and reliably managing the goal of client satisfaction. Quality Management System could be implemented both at the organisational level and at the project level itself.

The purpose of this survey is to get feedback on the importance of Quality in construction projects and the tools and methods used to manage it, including implementation of Quality Management System. The questionnaire for the survey is being sent out to key stakeholders related to projects, such as, engineering consultants, contractors and clients/ owners including the government, to elicit responses for developing an overall understanding of prevailing situation and possible approach for improvement in the same that could be shared with all concerned to implement suitable actions/measures.
